- The 2022 NSBA World Show was a huge success, with over \$1.4 million in cash and prizes awarded to exhibitors due in part to the \$273,000 increased added money from NSBA.
- The 2022 Markel Insurance BCF Yearling Sale was another record setting sale bringing over 2 Million dollars, raising a graduate purse estimation to be \$210,000.
- Smart Point continues to be one of the most popular NSBA programs with horse enrollments rising after a record payout in 2021 with \$56 per point
- Heroes on Horses entry numbers and interest continue to grow every year and expanded to a third location at the Arizona Sun Circuit where a boot camp, dinner and competition were held and will be again in 2023.
- Benefits from NSBA programs extend beyond the exhibitor & owner. 2022 recognized more professionals, exhibitors, and horse enthusiasts through the newly created Dianne Eppers Cowgirls ROC along with the established Hall of Fame, Quarter Million Dollar Club and Youth of the Year. The NSBA Foundation supports that by funding outreach programs and scholarships.

In the 20 years I've been involved in NSBA, there has been tremendous growth. The office moved to Gurnee, IL in 2007. As the new executive, Dianne took us to a level of examining details of every program and evaluating it for its strengths and weaknesses, and improving on each. The building was purchased there in 2014. Stephanie became the executive in 2020. Here are a few comparisons from the last 10 years:

2021 Financial report prepared by the CPA firm of Warady & Davis presented by Stephanie Lynn, Executive Director.

The financial report is a consolidated statement of activities, functional expenses and cash flow for the years end of the National Snaffle Bit Association and the National Snaffle Bit Association Foundation. The financial statements of not for profit organizations show assets and revenues, gains, expenses and losses classified as "with donor restrictions and without donor restrictions based on the existence or absence of restrictions.

The report shows as of Dec 31, 2021 current assets of \$5,152,073 up 1.8 Million from 3.2 million in 2020.

Revenues without donor restrictions totaled 7,188,000 with Expenses of 5.8 million dollars.

Net Assets increased 1.4 million dollars from 2020.

The Cash Flow from Operating Activities show \$1.4 million with cash and cash equivalents ending at \$3,157,000.

The report shows deferred revenue consisting of BCF enrollments, prepaid memberships, and stallion incentive funds totaling \$2 million dollars.
