2023 World Show – presented by Barnes, schedule draft, new \$1,500 late fee after 5PM (must already be entered/assigned back number), discussion of adding sale graduate late fee - no action

2023 Yearling Sale - presented by Kaven, updates to consignment contract (noted as underlined):

2. All consignments are subject to acceptance by the Sale Management and consignment fees for accepted yearlings are non-refundable. Sale Management will refund the consignment fees for yearlings that are not accepted into the sale. Consignment fees of \$650 are available for consignors tendering cash or checks drawn on American banks with this signed Consigned Contract by June 1, 2023. There will be a convenience fee for consignments paid by credit card. Foreign checks must be payable in US funds. After June 1, 2023 a \$100 late fee will apply, if sale is not full.

3. Due to the limited number of consignments accepted the following consignment policies will be adhered to.

a. Limit of five consigned yearlings per owner/legal entity/family member in the same household.

b. Any yearling that has been transferred after March 1st of the sale year is subject to review. 4. Check-In protocol for received consignment contracts:

a. All entries will be date stamped in the order they are received. Entries will begin being accepted April 1st and close June 1st. Entries arriving prior to April 1st will be date stamped on the day received however will not be processed until April 1st.

b. Entries with all required documents (excluding pending breed papers) and full payment will be accepted before entries with missing documents and/or payment.

8. Consignor agrees that if a consigned yearling is privately sold or withdrawn at consignor's request, substitute consignments will be accepted until July 20, 2023. Consignor will tender to Sale Management an additional fee of \$350 with each substitution. Substitution fees for NSBA sponsors will be \$100. If the consignor fails to present any consigned yearling for any reason other than stated in paragraph 7 or substituted as discussed above, the consignor forfeits the consignment fee and agrees to pay the Sale Management on demand a fee of 8% of sale price if sold or \$2000 whichever is greater

as liquidated damages, not as a penalty. <u>Once the catalog has been indexed from the pedigree</u> researcher no additions or changes will be made except for substitutions by an original consignor.

16. An original health certificate (<u>one yearling per certificate</u>) dated no earlier than thirty (30) days prior to the sale date and an original negative Coggins test dated no earlier than six (6) months prior to the sale date must be provided to the Sale Management at the time of check in at the Sale Management office.

20. The Sale Management does not warrant or guarantee the authenticity of validity of any statements relating to genetic defects such as including but not limited to HYPP or and HERDA.

a. All entries will be date stamped in the order they are received. Entries will begin being accepted April 1st <u>February 15th</u> and close June 1st. Entries arriving prior to April 1st will be date stamped on the day received however will not be processed until April 1st.

Year End High Point Tabulations Options

Proposed NSBA Year End Award: Combine base points and NSBA points. This system awards base points on the number of horses beat, up to a maximum of 10 points. In all classes, regardless of the number of entries, base points are added to NSBA Points earned. Point calculation in classes with less than 11 entries:

Example A:

A horse placing first out of nine (1/9) would receive 1 NSBA Point and 8 Base Points for a total of 9 points. The second place (2/9) horse would receive $\frac{1}{2}$ NSBA Point and 7 Base Points for a total of 7 $\frac{1}{2}$ points.

A horse placing first out of 2 (1/2) would receive zero (0) NSBA points and 1 base point for a total of 1 point.

Point calculation in classes with more than 11 entries:

A horse placing first out of 15 entries (1/15) would receive 3 NSBA points and the maximum base points of 10 for a total of 13 points. The second place horse (2/15) would receive 2 NSBA points and 9 base points for a total of 11 points.
