## T. Joe Jeane Memorial Scholarship

### **Criteria for Application**

The NSBA Foundation provides oversight of this recurring 3-year scholarship in memory of T. Joe Jeane. It will be awarded to a second-year Veterinary Medicine student attending an AVMA accredited institution.

The scholarship is a \$4,000 scholarship given for three consecutive years, not to exceed \$12,000.

#### **Application Process**

Applications open December 1st for students in their first year of Veterinary Medicine School. Deadline for application is February 1<sup>st</sup> with the announcement of the winner in May. The first payment will be made in the Fall of the recipient's 2<sup>nd</sup> year of Veterinary school. Application may only be submitted electronically through NSBA. No paper applications will be accepted.

#### Candidates for consideration must:

1) Be an NSBA member in good standing for at least one year or any of its breed affiliate members.

- 2) In their first year of Veterinary School with large animal emphasis.
- 3) Cumulative grade point average of 3.0 on a 4.0 scale (or equivalent)
- 4) Previous year's transcripts to be submitted annually by July 1st for continued disbursement
- 5) Maintain enrollment in the same or equivalent program

Applications must include: Current NSBA or breed affiliate membership and membership ID number

- □ First page of previous three year's federal income tax returns (personal)
- □ A copy of your official academic transcript to upload (to date)
- Three (3) reference letters in <u>one</u> file to upload (all references must be unrelated adults, over 21)
- □ A digital photo, 300 dpi
- □ Completed answers to the all below questions

# Applications will be reviewed based on the following criteria, in order of significance: financial need, academic merit, involvement in the equine industry and community involvement. All listed materials must be included in application. Failure to include all materials will result in application.

Scholarship funds will be paid directly to the institution and will not be issued to the student or his/her family. If awarded the T. Joe Jeane Memorial Scholarship, it is the exclusive responsibility of the recipient to notify the NSBA Foundation office with the contact information for their school's financial office. Since the scholarship awarded is a multi-year scholarship, the student must maintain a 3.0 GPA to receive funds each subsequent year maintain enrollment in the same or equivalent program. Scholarship funds are to be used primarily for tuition, books, and laboratory fees. The scholarship application and the supporting material become the property of the NSBA Foundation and will not be returned.
