When applying to become a NSBA Steward, please remember the following:

- 1. Must be at least 25.
- 2. Must be a current NSBA member in good standing member to the year in which you apply.
- 3. Applicants must provide a copy of their steward credentials from one of the approved associations.
- 4. After the application is submitted and reviewed, applicants will be notified as to whether they have been approved for steward status. Incomplete applications will not be considered.
- 5. If you are approved for steward status, your name will be added to the permanent steward list and it will be mandatory to complete a recertification session after your first year as a NSBA Steward.

Please remember to submit:

- 1. \$100 application fee (non-refundable)
- 2. A recent head and shoulder photo in professional attire (NOTE: Your application will be considered incomplete without a photo).
